# 1. District Council & County Council Reports:

## 2. Highways Issues:

The Street: ongoing issues Update –

Earl Warren has had repairs carried out to 'sink-holes but no further news regarding main issue of backfill failure. No date fixed between Highways/Barhale contractor for any review or survey. Chairman to re-enquire with NCC Highways ref. ongoing concerns.

NCC Drainage Department has been instructed to install 2 Silt traps - this work to be carried out during Jan 2018.

Work had been carried out during previous week to clear road drains opposite Bretwick House including a camera survey of the affected surface water drainage pipework at that location.

Highways foreman in charge had commented that the adjacent pond might require cleaning out and possibly also the pond opposite the Church.

Format of the Board has changed – Sam Chapman- Allen is now Chairman.

SC-A reported on focus for the future, Council and District Council Agendas to be driving matters forward to enable positive results. Sub-Groups are on the whole working fairly well.

Good public turnout at the last meeting held 15<sup>th</sup> November 2017. A local businessman expressed concerns that Thetford needs more social / affordable housing, this being directed at the SUE.
